*Safety Report* (Vicki Love) – Committee is revising a list for Paul.

*Teen Report* (Kathy Doulabi) – In the process of booking DJ's for teen dances.

### **New Business:**

Board asked owners to give their opinions regarding the use of motorized scooters on the Ranch. A motion was made to ban these scooters – vote was 2 for the ban and 3 against. Board voted and approved that the use of motorized scooters on the Ranch be restricted to persons 16 years of age or older with a valid driver's license. This matter will be reviewed again if scooters become a problem.

Announcements to run for the Board must be turned in to the ROA office along with a written statement by the June 15, 2002 deadline. Starting in August 2002, the directors will serve two year terms as explained in the revised by-laws.

In order to vote, an owner must be current with assessments thirty days prior to the election. Board voted and approved the record date for this election to be July 19, 2002.

*Election Procedures/Inspections* – Votes will be counted in the lodge in view of the owners. Votes will be by ballot only, no proxies. The Board voted and approved the use of an outside observer to monitor the election and they will use the same person as last year.
